Vehicle Registration

Reminder - All residents are to register their vehicle with the Housing Authority Office. You will need to submit proof of registration of the vehicle and a description of the vehicle. Any vehicle that is not registered will be towed at owner's expense! Furthermore, each time you get another vehicle, you have five (5) days to register the vehicle.

Window Air Conditioners Must be Removed by October 31st

In accordance with your lease, all window air conditioners must be removed from all windows by October 31st. Any tenant that does not comply will be tagged. If Maintenance Personnel is dispatched to remove any air conditioner, a charge of \$20.00 *per air conditioner* will be posted to your account. Please remember that in addition to removing the unit, all screens must be in good repair and re-installed. Please contact the Maintenance Department during normal business hours if you require assistance in re-installing any screen. If no repairs are needed, there is no charge for this service.


