Reporting Your Income

In reviewing a list of tenant accounts, there are quite a few tenants that have failed to report an increase in their income and now owe back rent. You have ten (10) days to report a change in your income. Those tenants that are working a seasonal job, you still have to report the job and income too, even though it is not used in the rent calculation, it does have to be reported to HUD.

Late Fees

Effective January 1, 2022, the Late Fees process will be re-instated. Rent is due by the 5th day of the month. CHG will charge a fee of \$5 on the 6th day of the month. Thereafter, CHG will charge \$1 for each additional day the rent remains unpaid during the month it is due.

Renters Insurance

Due to recent events at one of our properties, we cannot recommend strongly enough for you to consider purchasing Renters Insurance.

Renters insurance provides important coverage for both you and your possessions. There are a number of different insurance companies that provide renters insurance at an affordable fee. You can google it on your phone and get the phone numbers of different agencies in our area that offer renters insurance and compare the costs. For Pets or Support Animals at all Properties:

There is a process and procedure for having a pet or support animal. You may NOT bring the animal on to the property or in your unit until the entire process has been completed. If/when you are fully approved, you will get a letter and permit from housing. If you are denied, you will get a letter from housing. If you are unsure of the process, please call Jaime Thomas at 301-724-6606 ext. 106. You may NOT bring the animal to your apartment and then request a pet or support animal. You MUST do all the required steps first.

STAY WARM

Conserve Energy by:

- -Keep drapes & blinds open during the day on windows facing the sun so that any available sunshine will be absorbed indoors.
- At night, keep drapes and blinds closed and they will act as an insulator to keep heat inside and keep out chilly drafts.
- Do not open windows in cold weather,
- Do not block air registers with furniture and/or curtains.
- Kerosene heaters are **prohibited** by the HACC and the State Fire Marshal.
- Electric heaters will be permitted which have a safety control for tipping, a cut off when a certain temperature is reached, a control for the amount of time it stays on and are currently UL certified.
- Do not turn oven on to use for heat.
