Parking @ JFK and Queen City Tower

Parking at JFK is designated. If you have a vehicle, please see Lorri Wharton, Property Manager, to get an assigned parking space, and numbered tag. Please make sure that your family members, visitors, and guests do not park in any numbered spaces. They will risk being towed. There are 4 spaces marked for guest parking on the lot, as well as short term parking in the front of JFK. Parking out front is not for overnight parking. Remember all guests need to sign in on the guest sheet by the elevators.

Queen City Tower

Parking at QCT is not designated, and is on a first come first available basis.

Copy of Registration Cards

If you are a tenant and own a vehicle, you must give a copy of your registration card and proof of insurance to the main office at your development.



COVID – 19 Information

To get the latest on the COVID-19 Vaccine, call the COVID-19 call center at 240-650-3999.

The Allegany County Health Department continues to offer free COVID-19 vaccinations for individuals ages 12 and older at the Allegany County Fairgrounds from 9 a.m. to 1 p.m. No appointment is needed for first and second doses of Moderna vaccine (ages 18+) and first, second, and booster doses of Pfizer vaccine (ages 12+). Appointments are recommended for the Moderna booster vaccine and individuals may schedule an appointment by visiting http://health.maryland.gov/allegany and clicking on the preferred clinic date.

For assistance registering for an appointment, county residents can call the COVID-19 call center at 240-650-3999. COVID-19 vaccines and boosters are also widely available at local pharmacies, urgent care clinics, and some primary care providers.

Free drive-thru COVID-19 testing is still being offered at the Allegany County Fairgrounds (11400 Moss Ave, Cumberland) on Mondays from 2 to 7 p.m. and on Wednesdays and Fridays from 8 a.m. to 2 p.m.

Risk Control Policy

The Cumberland Housing Group considers the safety of its residents, its staffers, and other members of the public who come in contact with its facilities or services to be of utmost importance. The Cumberland Housing Group will not tolerate unsafe acts or conditions created by its staffers or tenants. It is a positive responsibility of the Cumberland Housing Group staffers and tenants to bring any and all unsafe conditions promptly to the attention of management. All concerned are expected to adhere to the safety rules and procedures relevant to their employment or residency responsibilities, including such matters as safe driving, proper use of equipment and appliances, and adequate supervision of and concern for small children. Fulfillment of safety responsibilities should be considered in the performance evaluation of each Cumberland Housing Group staffer. The Cumberland Housing Group commits to make every effort to comply with all local, state and federal safety and health regulations and to enforce the policies and procedures set forth in its own Risk Control Guide and related health and safety plans.

Affordable Connectivity Program

The Affordable Connectivity Program is an FCC benefit program that helps ensure that households can afford the broadband they need for work, school, healthcare and more. The benefit provides a discount of up to \$30 per month toward internet service for eligible households and up to \$75 per month for households on qualifying Tribal lands. Eligible households can also receive a one-time discount of up to \$100 to purchase a laptop, desktop computer, or tablet from participating providers if they contribute more than \$10 and less than \$50 toward the purchase price. The Affordable Connectivity Program is limited to one monthly service discount and one device discount per household.

Who Is Eligible for the Affordable Connectivity Program?

A household is eligible for the Affordable Connectivity Program if the household income is at or below 200% of the <u>Federal Poverty Guidelines</u>, or if a member of the household meets at least *one* of the criteria below:

Received a Federal Pell Grant during the current award year;

- Meets the eligibility criteria for a participating provider's existing low-income internet program;
- Participates in one of these assistance programs:
 - The National School Lunch Program or the School Breakfast Program, including through the USDA Community Eligibility Provision;
 - SNAP
 - Medicaid
 - Federal Public Housing Assistance
 - Supplemental Security Income (SSI)
 - WIC
 - Veterans Pension or Survivor Benefits
 - or Lifeline:
- Participates in one of these assistance programs and lives on <u>Qualifying Tribal lands</u>:
 - Bureau of Indian Affairs General Assistance
 - Tribal TANF
 - Food Distribution Program on Indian Reservations
 - Tribal Head Start (income based)wo Steps to Enroll

Apply Now

- 1. Go to AffordableConnectivity.gov to submit an application or print out a mail-in application.
- 2. Contact your preferred participating provider to select a plan and have the discount applied to your bill.

Some providers may have an alternative application that they will ask you to complete. Eligible households must both apply for the program and contact a participating provider to select a service plan.

How Does the ACP Protect Consumers?

FCC rules protect Affordable Connectivity Program recipients by:



- Empowering consumers to choose the service plan that best meets their needs (including a plan they may already be on);
- Ensuring consumers have access to supported broadband services regardless of their credit status;
- Prohibiting providers from excluding consumers with past due balances or prior debt from enrolling in the program;
- Preventing consumers from being forced into more expensive or lower quality plans in order to receive the ACP;
- Ensuring that consumers are not liable for early termination fees;
- Reducing the potential for bill shock or other financial harms;
- Allowing ACP recipients to switch providers or broadband service offerings; and
- Providing a dedicated FCC process for ACP complaints.
