Snow Removal

A major concern during winter is the clearing of ice and snow. Residents of Jane Frazier Village, River Bend Court & Banneker Gardens are responsible for clearing ice and snow from the front and rear sidewalks leading to their units within 24 hours of the end of precipitation as per City of Cumberland ordinance. Residents who fail to promptly clear their walks within that time will be charged when the Maintenance Department has to perform the work. Residents should exercise good judgment in placing snow that they remove from the walks. Never throw it out into the streets or other areas where your neighbors or the Maintenance Department will have to move it again. Do not place shoveled snow against the building or foundation. Please do not use salt or other chemicals on your walks as they damage the concrete, grass and plants. You can use kitty litter. The Maintenance crews get to the public walks and drive areas as soon as possible. Residents may be required to move their vehicles to allow for clearing of snow.

Extreme Temperatures

With the recent extreme temperatures, here are some important reminders in case of another artic blast:

- In the family developments, leave kitchen cabinet doors open so that the pipes have some heat exposure to keep from freezing.
- Do not block heaters with furniture, curtains, boxes or clothes. Keep several feet of distance from the heater so heat can flow freely.
- Especially in negative temperatures with wind chill factors, if there is heat coming into your apartment, but it is not as much as you prefer, understand that the boilers are doing what they can to keep up. If the heaters are still warm/hot to the touch, there is no need to call Maintenance. Most of our properties operate on a boiler system, which makes both heat and hot water. At some parts of the day, it may seem cooler as the system makes hot water and then switches back to heat.
- If you live at Banneker Gardens, your heating system could run constantly to keep up. The temperature on the thermostat versus what you set it on, may never get to the temperature you desire. Again, the system will do what it can to supply the demand. If the air is warm coming from the vents, the system is working.
- NEVER HEAT YOUR APARTMENT WITH AN OVEN! This can cause severe injury and possible death.
- If you feel you need some added warmth on extremely cold days, you may want to consider purchasing an approved space heater. Your lease addresses the correct type of heater that you can purchase. Make sure there is enough clearance around a space heater when in use, and do not leave it unattended.

ALL of our tax sites are operating on an APPOINTMENT basis. However, walk-ins will be accepted on a limited basis at the CUMBERLAND site ONLY, but you must have all required documents with you (list available on HRDC's website or by calling the tax line at 301-783-1800.

If an in-person appointment is not for you, call the tax line for drop off options.

EARNED INCOME TAX CAREDIT (EITC)

If you worked in 2023 and your Adjusted Gross Income (AGI) is not greater than the amount listed for your household type in the chart below, you may be eligible for an EARNED INCOME TAX CREDIT (EITC)

Children or Relatives claimed:	HoH, Widowed or Single Filers:	Married Filing Jointly:	Maximum EITC:
0	\$17,640	\$24,210	\$600
1	\$46,560	\$53,120	\$3,995
2	\$52,918	\$59,478	\$6,604

Workers who are not claiming children/relatives must between the ages of 25 and 64, not be the dependent or qualifying child of another person and must have lived in the United States more than half of the year to be eligible for the EITC.

To be a qualifying child for the EITC:

- The child can be your son, daughter, adopted child, stepchild, foster child or grandchild; your brother, sister, half-brother or half-sister, stepbrother or stepsister; or grandchild, niece or nephew.
- The child must be under 19 at the end of the year and younger than you or your spouse if you're filing jointly, OR the child must be under 24
 and a full-time student for at least 5 months of the year and younger than you or your spouse if you're filing jointly OR any age and
 permanently and totally disabled at any time during the year.
- The child must have lived with you or your spouse in the United States for more than half the year. If the child can file a joint return with another person (for example, their husband or wife), you may not be able to claim them Investment income for the year: \$11,000 or less

HRDC trained tax staff will also ensure you receive all credits you may be eligible for.
