JFK RESIDENTS

As you know, the trash chutes are not usable. The garbage is being removed at least once per day during normal business hours by staff and construction crews. It has been brought to our attention that tenants are not properly bagging their garbage before putting it in the designated area. No loose trash should be deposited into the bin or in the area. All trash must be bagged properly, tied to prevent items from spilling out, any bags with holes in them should be double bagged. Do not put items with liquid that can spill out in the bags. Rinsing containers will help keep smells limited.

It has also been noticed that bulk items are being deposited in the trash collection area. **THIS PROCESS HAS NOT CHANGED!** Bulk items need to be placed by the dumpster on Sunday evenings only.

Everyone needs to do their part while this construction progresses.

When it snows, please wait for maintenance to clear sidewalks and walkways before going out. Compacted snow can turn to ice, and cause injuries.

ALL of our tax sites are operating on an APPOINTMENT basis. However, walk-ins will be accepted on a limited basis at the CUMBERLAND site ONLY, but you must have all required documents with you (list available on HRDC's website or by calling the tax line at 301-783-1800.

If an in-person appointment is not for you, call the tax line for drop off options.

EARNED INCOME TAX CAREDIT (EITC)

If you worked in 2023 and your Adjusted Gross Income (AGI) is not greater than the amount listed for your household type in the chart below, you may be eligible for an EARNED INCOME TAX CREDIT (EITC)


Workers who are not claiming children/relatives must between the ages of 25 and 64, not be the dependent or qualifying child of another person and must have lived in the United States more than half of the year to be eligible for the EITC.

To be a qualifying child for the EITC:

- The child can be your son, daughter, adopted child, stepchild, foster child or grandchild; your brother, sister, half-brother or half-sister, stepbrother or stepsister; or grandchild, niece or nephew.
- The child must be under 19 at the end of the year and younger than you or your spouse if you're filing jointly, **OR** the child must be under 24 **and** a full-time student for at least 5 months of the year and younger than you or your spouse if you're filing jointly **OR** any age **and** permanently and totally disabled at any time during the year.
- The child must have lived with you or your spouse in the United States for more than half the year. If the child can file a joint return with another person (for example, their husband or wife), you may not be able to claim them Investment income for the year: \$11,000 or less.

HRDC trained tax staff will also ensure you receive all credits you may be eligible for.

My Groceries to Go

Extreme Temperatures

With the recent extreme temperatures, here are some important reminders in case of another artic blast:

- In the family developments, leave kitchen cabinet doors open so that the pipes have some heat exposure to keep from freezing.
- Do not block heaters with furniture, curtains, boxes or clothes. Keep several feet of distance from the heater so heat can flow freely.
- Especially in negative temperatures with wind chill factors, if there is heat coming into your apartment, but it is not as much as you prefer, understand that the boilers are doing what they can to keep up. If the heaters are still warm/hot to the touch, there is no need to call Maintenance. Most of our properties operate on a boiler system, which makes both heat and hot water. At some parts of the day, it may seem cooler as the system makes hot water and then switches back to heat.
- NEVER HEAT YOUR APARTMENT WITH AN OVEN! This can cause severe injury and possible death.
- If you feel you need some added warmth on extremely cold days, you may want to consider purchasing an approved space heater. Your lease addresses the correct type of heater that you can purchase. Make sure there is enough clearance around a space heater when in use, and do not leave it unattended.
