2024 City of Cumberland Community Development Block Grant Program

City of Cumberland Community Development Staff announces the Community Development Block Grant (CDBG) 2024 Annual Action Plan proposed projects for funding. These 13 projects fall under one of three categories: Facilities/Infrastructure, Admin/Planning, and Public Services for a total of \$800,000; the estimated award from the U.S. Department of Housing and Urban Development. If the actual award from the U.S. Department of Housing and Urban Development is less than or more than the estimated amount, the contingency plan is to subtract or add those funds as appropriate to the total award for the Parks and Recreation Improvements project identified below. These proposed CDBG projects will be presented at the second Public Hearing for CDBG during the regular Mayor and City Council meeting on Tuesday, April 2, 2024 and are expected to appear on the agenda for approval at the regular Mayor and City Council meeting on Tuesday, May 7, 2024.
