## Important Reminder's... These are Lease Violations

With warmer months approaching, please keep in mind, <u>you must clean up</u> after your pet or Emotional Support Animal.

We are a federal property and there is to be **NO** marijuana on the property. By Federal standard, it is illegal to have on our properties whether you have a medical marijuana card or not.

#### **HOUSEHOLD TRASH**

Household trash is to be taken to and placed inside of the dumpsters provided on site. No loose bagged or boxed garbage or trash is to be left outside of the rental unit as this is a serious health violation. Household trash is not permitted to be placed in the common area trash cans which are located on the property. Do not send anyone to put garbage in the dumpster unless they can place it inside. Garbage is NOT to be left on the ground.

A lease violation will be issued, and a charge as listed on most recently approved Schedule of Tenant Charges will be charged per bag/box and will be posted to your rent statement for any garbage bag/box left outside of your unit (will be considered trash regardless of the content) or outside of the dumpster.

#### **Renters Insurance for Your Personal Property**

Rental Insurance may be obtained through any insurance agent and is used to protect you from loss not covered by the CHG. This insurance is not required but the CHG strongly recommends that each household purchase this inexpensive protection for their personal property. In the event of a building fire, flood, break in, theft, roof leak, water or sewer overflows, vandalism or any other number of accidents or catastrophes, the buildings are insured by the CHG but not your personal property. Whether caused by the CHG, you or by another tenant or guest, any damage incurred to your personal belongings is your sole responsibility not the CHG.

#### My Child Just Turned 18, Now What Do I Do?

You will need to contact your Property Manager to sign a new lease. All adults 18 and older are required to sign the lease and other Housing documents. Please be sure to provide school/work information of the child that just turned 18 to the Property Manager.

#### **Need a Birth Certificate?**

If you were born after 1940 in Maryland, go to the Allegany County Health Department, 12501 Willowbrook Road, Cumberland. Hours of Operation: Monday through Friday, 8:00 am to 3:30 pm

- Cost \$20.00 payable by cash, local check, Visa, MasterCard and Discover.
- Certified birth certificates can be acquired within a half hour if all guidelines are met.
- Government issued ID required: valid driver's license, United States Passport, DMV photo ID card, military photo ID.
- NO side view photo ID's, ID's that are expired, cracked, chipped, broken or peeling will not be accepted.
- ID's must include an issue date and an expiration date. If the ID does not include a full middle name, an additional form of ID will be required, such as a Social Security Card.
- There is no fee for a copy of a birth certificate of a current or former armed forces member. Specific documentation is required for the military. Call 301-759-5119 for more information.
- Birth certificates for years prior to 1940 must be requested from the Division of Vital Records, 6550 Reisterstown Road, Baltimore, MD 21215. The fee is \$10.00 when applying to the Baltimore office.

#### **Need a Photo ID?**

- The MVA is located at 13300 Winchester Road SW Cumberland. Phone is 410-768-7000.
- Hours of operation are Monday-Wednesday and Friday: 8:30am 4:30 pm, Thursday 8:30 am 6:30 pm and Saturday from 8:00 am 12:00 pm. You must make an appointment.
- There are no age requirements to obtain a Maryland identification card.
- Bring proof of identity and date of birth such as a birth certificate or a valid United States Passport.
- Bring 2 documents proving your Maryland residency such as a utility, telephone, cable or satellite bill, property tax bill, MD vehicle registration, vehicle insurance card, checking or savings account statement, residential rental contract, deed or proof of home ownership, mail from a federal, state or local government agency, credit card statement, selective service card. The utility bill, etc. should be within the last 6 months.
- Bring proof of your social security number such as original social security card, recent W-2 or 1099 form or proof of
  ineligibility. All copies must be original, certified, or true test copies. Be certain that the 1099 contains your full Social
  Security number.
- Fee is \$15 for younger than 18 years old, \$24 for older than 18 years old. Duplicate cards are \$20. Older than 65 and disabled residents are free.

- The Social Security office is located at 217 Glenn Street, Suite 100 in Cumberland close to the Downtown YMCA and the VA clinic. Phone number is 866-964-7409.
- Hours are Monday through Friday from 9:00 am 4:00 pm.
- Call 1-866-964-7409 from 9 am to 4 pm or 1-800-772-1213 between 7 am and 7 pm, Monday through Friday if you have any questions.
- Documentation you should bring (if available): MVA ID card, Driver's license, medical assistance card, and/ or valid

Any additions to the household including Live-in Aides and foster children, but excluding natural births, adoptions. and court awarded custody require the advance written approval of the CHG. Such approval will be granted only if the new family members pass the CHG's screening criteria and a unit of the appropriate size is available. Permission to add Live-in Aides and foster children shall not be unreasonably refused. Tenant agrees to wait for CHG's approval before allowing additional persons to move into the premises. Failure on the part of tenant to comply with this provision is a serious violation of the material terms of the lease, for which the CHG may terminate the lease. Tenant shall report deletions from the household (for any reason) to the CHG in writing, within 10 days of the occurrence.

### Now accepting applications!

HAI Group's Resident Scholarship Program helps low-income students pay for higher education. To date, we have awarded more than \$1.6 million to nearly 500 students across the country—students who have gone on to careers in nursing, education, social work, and more.

Resides in a housing authority or in a property with a housing choice voucher (HCV) administered by a housing authority that is a member of Housing Authority Risk Retention Group (HARRG) or Housing Authority Property Insurance, A Mutual Company (HAPI) or resides in an affordable housing property insured by Housing Enterprise Insurance Company (HEIC).

#### Citizenship

Must be a United States citizen or a permanent resident (with a green card).

#### Other

Must follow all other rules outlined in the official rules.
