30 Day Tenant Comment Period Ends May 9, 2024 on Changes to Lease Attachment No. 6 Pet Ownership Policy

Cumberland Housing Authority is holding a thirty-day comment period for changes to Lease Attachment No. 6 Pet Ownership Policy. There are minimal changes, and this is mostly due to the new JFK Apartments that recently went through the Rental Assistance Demonstration (RAD) transition.

The information referenced above is available for review at the Central Office of the Cumberland Housing Group located at 635 E. First Street, Cumberland, or any of our staffed site offices during the hours of 8:00 AM to 4:00 PM Monday through Friday, (except Holidays) or at www.cumberlandhousing.org. Public comments can be submitted in writing to any Property Management office by 4:00 P.M. on May 9, 2024.

New Fire Alarm System

A new fire alarm system will be installed over several months. Some wiring has already begun in the common areas. You may hear the contractor working in the building during the coming weeks. Please avoid where their ladders are set up if possible. At some point, they will need access to every apartment. A notice will be sent out to residents when the contractor notifies the agency when this is to occur.

Medical Marijuana

Any form of Marijuana, including gummies, pills, etc., is not allowed on any Federally assisted property, as this is a Schedule 1 controlled substance and illegal under Federal Law. The use of Medical Marijuana is prohibited by Federal Law on all properties or in your unit.

If evidence is found that any form of use or possession of Medical Marijuana, on the property, violators will be issued a notice to vacate.

Assistance Animal and Pet Owners!

The following documents must be submitted for your annual renewal when your permit expires:

- Application with completed vet certification (on backside)
- All updated immunization records, including rabies certificate
- Photo of flea treatment used in the last six months.
- Current Allegany County Dog license (if dog owner)
- Updated photo of the animal

If you have any questions regarding your permits or renewal documents, please contact the coordinators below:

Notices and applications are sent out 30 days before the permit expires. Updated documentation is required every year as stated in the lease. Failure to comply will result in a lease violation and/or your permit being revoked.
